## Request

- 1. How many patients were treated in the last 12 months (for any disease) with:
  - a) Ethambutol + rifampicin + Clarithromycin/azithromycin
  - b) Ethambutol + rifampicin + Clarithromycin/azithromycin with the addition of injectable (IV) or nebulised Amikacin
- 2. How many patients have been diagnosed in the last 12 months for the following diseases?
  - a) Non-tuberculosis mycobacterium (NTM) (ICD10 codes: A31.0/A31.9)
  - b) Bronchiectasis (ICD10 codes J47/Q33.4)
- 3. Which other hospital trust or health care professional would you contact if you require advice on nontuberculosis mycobacterium (NTM) infections?
- 4. Do you discuss difficult to manage non-tuberculosis mycobacterium (NTM) patients as a Multidisciplinary Team (MDT)?

## Response

- 1. a) <5 patients were treated with this combination in the last 12 months.
  - b) 0 patients were treated with this combination in the last 12 months.
- 2. a) Non-tuberculosis mycobacteria have been isolated from specimens received from 10 patients in the period 01/07/21 to 30/06/22
