Response

- 1. NHS Borders have established a staff network on race equality.
- 2. This network forms one of several equality networks which NHS Borders has established or is in the process of establishing and which feed into and used for advisory purposes of our the Equality in Employment at Work Group. That group then feeds into the Area Partnership Forum, Staff Governance Committee and so to the Board of NHS Borders.
- 3. The network is led by ITU Physiotherapist and CSP Equality Rep Vineeth Ravindran, and includes domestics, nurses, medics, surgeons and healthcare support workers. We have a wide range of ethnicity represented on network.
- 4. As above, but all unions have access to the Equality in Employment Group.
- 5. In person 8 months ago and the network has an active WhatsApp Group.
- 6. Director of HR and OH&S and Employee Director are meeting with the network in October 2022.

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. Please state the reference number **434-22** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
