# Freedom of Information request 501-22

### Request

- 1. The Child Smile website says, "within priority schools, fluoride varnish application should be arranged for twice a year". Please provide confirmation of whether or not the fluoride varnish application was offered twice a year to each priority school and every eligible child within the last five financial years (2018/2019, 2019/2020, 2020/21, 2021/22, 2022/23)
- 2. The Childsmile website says "20% of children in each year group attending nurseries and primary schools are targeted for Childsmile". Please provide a breakdown of how many children within that targeted 20% were offered Childsmile services in the last five financial years (2018/2019, 2019/2020, 2020/21, 2021/22, 2022/23).
- 3. How many nurseries and primary schools have participated in Childsmile within the last five financial years (2018/2019, 2019/2020, 2020/21, 2021/22, 2022/23), with a breakdown?
- 4. How many children were eligible to participate in Childsmile within the last five financial years, and how many actually participated (2018/2019, 2019/2020, 2020/21, 2021/22, 2022/23)?

#### Clarification (05/10/22):

- Yes, academic year is acceptable if that's the way it's recorded.
- In Question 3 I am asking for a breakdown by year of many nurseries and primary schools have participated in Childsmile in the last 5 years.
- I would like the information on toothbrushing and fluoride varnish application

#### Response

- 1. The NHS Borders information below refers to the Academic Year i.e. August June of each year:
  - 2018/19 Yes, the fluoride varnish application was offered twice a year to each priority school and every eligible child.
  - 2019/20- Yes, the fluoride varnish application was offered to all schools and nurseries until we received word to stop the programme in March 2020 due to Covid-19. Some schools, because of the onset of the pandemic, did not receive a visit but they were offered it.
  - 2020/21 No, the COVID-19 pandemic halted all work in schools, therefore, no fluoride varnish applications were able to be offered.
  - 2021/22 Authorisation was received from the Chief Dental Officer in August 2021 that fluoride varnish applications could be remobilised. NHS Borders provided a partial and phased return for the 2021/2022 Academic Year due to COVID disruption (lockdowns, isolation, school closures, staffing etc). The offer was initially made to the most deprived schools 2 priority schools were offered 2 applications, and a further 3 priority schools were offered 1 application over the year.

2022/2023 – To date, the 1st fluoride varnish applications are in the process of being offered. It is expected that the 2nd applications will also be offered during this Academic Year.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
