- 4. The electronic Finance System used by NHS Borders does not detail the charge for each individual shift but is a consolidated invoice from the relevant Agency Nursing supplier. To identify this information would require a manual trawl of all invoices received for Agency Nurse shifts worked during this time period and the cost of carrying out this work would exceed the limit set in the Fees Regulations of the FOI(S)A 2002 therefore under Section 12 cost of compliance we are not required to provide.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
