- The word 'Inappropriate' suggests that the patient placements are not clinically suitable for the patients. For clarity and purposes of this FOI inappropriate referrals' are seen to mean where there is no National or local Service Level agreement (SLA) in place with the provider the patient has been placed with out of area and not a reference to the clinical necessity.
- The years provided are from NHS financial year from 1st April to 31st March in each year until 2022/23 where the data is available until December 22.
- Only Elective activity for acute mental health is included (not emergency admissions).
- Only NHS Borders funded patients are included Q1-Q6 (excludes NSD funded) to avoid double count.
- Activity does not include patient placements where the main diagnosis and admission is that of learning disability.

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. Please state the reference number **21-23** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
