Please also provide the data for the financial years 2021-22, 2020-21, 2019-20, and 2018-19 and please also break this down by procedure.
- In relation to Qs1-2, what was the average distance of the transfer in miles during the financial year 2022-23? Please also provide the data for the financial years 2021-22, 2020-21, 2019-20, and 2018-19. This would be the distance from the place of referral to the place of treatment e.g from GP in Grampian to hospital in Tayside.
- 4. In relation to Qs 1-2, what was the furthest transfer in miles during the financial year 2022-23? Please also provide the data for the financial years 2021-22, 2020-21, 2019-20, and 2018-19.
- 5. In relation to Question 4, please provide a reason why that transfer took place. For instance, was it because of a lack of beds?

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
