# Freedom of Information request 125-23

### Request

I am writing to ask a Freedom of Information request regarding the misdiagnosis of patients. More specifically, "How many patients have been misdiagnosed in your health board every year since 2007, or since the earliest available year that data has been kept."

### Clarification

- The system used by NHS Borders does not record complaints data using the term "misdiagnosis", however Under Section 15 Duty to Provide Advice and Assistance of the Freedom of Information (Scotland) Act 2002 we can advise that we are able to search using "wrong diagnosis" please can you confirm if this is appropriate for your request and you would like us to proceed with the request using the term "wrong diagnosis"?
- NHS Borders does not hold this data prior to 1 April 2011, please can you confirm if you would like us to provide data from this date and if it should be in calendar or financial year?

"Wrong Diagnosis" as the term and from 2011 in calendar year format would suffice, thank you.

### Response

This information is not held electronically. The data may be held in a patient's record, but to extract this data would require a manual trawl of all patient records and the cost of carrying out this work would exceed the limit set in the Fees Regulations of the Freedom of Information (Scotland) Act 2002 and under Section 12 we are not required to provide.

However, per the clarification above, we are able to provide the number of complaints recorded for "wrong diagnosis" – this information is shown in the table below:

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. The request for a review should include your name and address for correspondence, the request for information to which the request relates and the issue which you wish to be reviewed. Please state the reference number **125-23** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
