## Request

- 1. How many assaults on staff have been reported to the health board in each of the last two full calendar years and so far, this year? Please break the figures down for each year to give an indication of how many assaults were of a sexual nature and how many were not. If possible, please also break the figures down to show how many of the incidents related to nurses, doctors, and other departments.
- 2. How many legal cases have been raised against the health board in each of the last two full calendar years and so far, this year by public staff who allege the health board was at fault in some regard for the assault they were subjected to?
- 3. How much compensation has the health board paid out (either directly or through its insurance) to workers in relation to instances when they were assaulted in the course of their work?

## Clarification

In Question 2 "How many legal cases have been raised against the health board in each of the last two full calendar years and so far, this year by public staff who allege the health board was at fault in some regard for the assault they were subjected to?" – what is your definition of "public staff"?

Sorry, that should just say staff, not public staff.

As there were less than 5 payments made to staff the payments cannot be disclosed as given the rarity of such cases and the small populations within our rural communities, we believe the identity of the claimant(s) would be well known and release of this information would lead to the amount they were awarded being made public. This would breach our duties under the Data Protection Act 2018. We are therefore withholding this data under Section 38(1)(b) of the FOI(S)A 2002.

As the number of events in some areas are very small and in accordance with the Code of Practice for Official Statistics any number that is less than five, actual numbers and potentially identifiable information is withheld to help maintain confidentiality due to potential risk of disclosure. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
