Request

I am looking for information regarding the arrangements in your health board for providing antivirals and prophylaxis to patients previously classed as on the Highest Risk list (see End of the Highest Risk List - gov.scot (www.gov.scot)).

As such, can I request the following, broken down by the years 2021, 2022 and 2023 (most recent):

- 1. What are the policy guidelines/arrangements in your Health Board for providing antivirals or prophylaxis to patients with a COVID-19 infection?
- 2. How many people with a COVID-19 infection have been prescribed a) antivirals or b) prophylaxis?
- 3. How many people with a COVID-19 infection have been prescribed Molnupiravir a) within 5 days of Covid symptoms or b) after 5 days?

Clarification

Regarding Question 2, NHS Borders do not record prescription data based on a diagnosis, only on the medications prescribed, therefore, please can you identify the specific drugs you would like this information for?

Can I request information on both Remdesevir and Molnupiravir.

Response

1. Please find attached the policy guidelines followed by NHS Borders for providing antivirals or prophylaxis to patients with a COVID-19 infection:



2. & 3. The NHS Borders protocol was only to give antivirals within 5 days of Covid symptoms, therefore prophylactic antivirals were not prescribed. The number of patients prescribed antivirals is:

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
