Freedom of Information request 353-23

Request

I am just looking for information regarding the number of patients who have been classed as a failed discharge. I'm not sure if your Health Board uses this definition?

In short, I want to know if patients have been discharged and then subsequently readmitted in a short period of time. As such, can I request the following:

- 1. A breakdown of the number of patients who were classified as a failed discharge since 1 January 2023 to 31 March 2023 or later [if this term is used] OR the number of patients who were discharged and then readmitted after 1 to 7 days with a breakdown for the same period.
- 2. The hospital and ward in which they were discharged and then admitted to.
- 3. The length of stay when readmitted.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
