- Specifically which drugs please? "other" drugs is too vague and we would be unable to provide data within the limits

Also, a note that Daily Defined Dose as a measure has to be 'hand built' per drug per strength, therefore the time to complete this report would be out with the cost of compliance and we would be unable to provide. A suggestion, if this query is going to each Health Board, it may be better to request this data from Public Health Scotland to get one answer or run the risk of the comparing "apples and oranges".

All the drugs would be ATOMOXETINE, CAFFEINE CITRATE, DEXAMFETAMINE SULPHATE, GUANFACINE HYDROCHLORIDE, LISDEXAMFETAMINE DIMESYLATE and METHYLPHENIDATE HYDROCHLORIDE.

If Daily Defined Dose as a measure would be out with the time of compliance, could the information please be supplied as number of items along with the number of patients as requested?
