Request

- 1. In 2023/24, how many 2C GP practices are there in this health board?
- 2. In relation to question 1: How many GP vacancies are there currently in these practices?
- 3. In relation to question 1: How many other vacancies are there in these practices? Please break this down by job type e.g practice nurse, dietician, receptionist etc
- 4. In relation to question 1: How many of these practices are currently not accepting new patients?

Response

- 1. NHS Borders has two 2C practices, Duns Medical Group and Leaderfoot. Please note that Leaderfoot is for challenging behaviour patients only.
- 2. Duns Medical Group currently has two GP vacancies. Leaderfoot has no GP vacancies.
- 3. Duns Medical Group currently has one Advanced Nurse Practitioner vacancy and one Receptionist/Medical Secretary vacancy. Leaderfoot has no vacancies.
- 4. Both practices are currently accepting new patients. However, NHS Borders does have a temporary restriction in place in relation to GP Practices lists which is as follows:
 - Patients who are already registered with a GP in their areas are able to apply to another practice for inclusion on their list of patients, however those practices are not obliged to accept them.
 - Noting that practices should continue to accept applications from patients that are new to the area.

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. Please state the reference number **446-23** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
