## Freedom of Information request 452-23

## Request

I will base my questions on the non-framework nursing agencies used by NHS Borders in the last three years.

- 1. Which department or person was responsible for recruiting/selecting such agencies? Please provide contact details, for example, the email address and the person's name.
- 2. Were such agencies recruited via the public advert, or did the agency representative have to contact a specific person or department with the offer?
- 3. What requirements did such agencies have to fulfil to be used by NHS Borders? What did the procurement/recruitment process look like? How long did the process take? What stages did the procurement/recruitment process involve? How long on average did the process to procure/recruit a single off-framework agency take?
- 4. Who decides which non-framework nursing agencies are used to fill a particular shift in clinical settings? For example, is it a hospital manager, a clinical nurse manager, or a charge nurse?
- 5. Is there any guidance stating which agencies should be used first and which should be used last? Are there any factors that impact those decisions, for example, the cost or the availability of staff?
- 6. Has there been any restriction on the number of non-framework nursing agencies that NHS Borders can use over a certain period, for example, over one year?
- 7. Did non-framework agencies have any limitations while collaborating with NHS Borders? For example, a maximum length of time that the agency could be used by the NHS Borders or a maximum amount of shifts the agency can cover in a certain period.

## Response

NHS Borders employs the use of Agency Nursing Services both directly and via the Regional Nurse Bank hosted by NHS Lothian, therefore data on nursing shifts is held by this authority. If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
