Request

- 1. During 2022/23, how much in total did NHS Borders spend sending patients to the private sector for treatment?
- 2. How many patients in total were sent to the private sector for treatment?
- 3. Which private facilities were used?
- 4. Please provide whatever breakdown you have available for these referrals (e.g. type of procedure, cost etc)

CLARIFICATION RECVD:

I would probably want all private referrals. However, if you are able to distinguish how many were done to meet waiting list targets, and how many were done to provide a service not available locally then please split them into separate categories when providing the response.

Response

- 1. The total spend by NHS Borders in 2022/23 sending patients to the private sector for treatment is £3,044,861. This total is made up of:
 - £1,551,645 for NHS Borders patients being treated within private facilities through the Extra Contractual Referral (ECR) process.
 - £1,493,216 for sending patients to private sector for treatment in relation to meeting waiting list targets (Waiting List Initiative).
- 2. There were 147 patients sent to the private sector for treatment. However, 28 waiting list initiative patients were rejected. Therefore 119 patients were treated.
- 3. The private facilities used were:
 - British Pregnancy Advisory Service
 - Cherry Tree Electrolysis
 - Cygnet Healthcare
 - Elysium Healthcare
 - Glasgow Centre for Reproductive Medicine
 - Harley Street London
 - Newcastle Clinic (Private)
 - Partnership in Care, Ayr Clinic
 - SK:N Clinics
 - Spire Washington

Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
