- 2. The longest waiting time for a coil fitting since 2018 is 4 weeks however, during lockdown in 2020 this increased to 12 weeks.
- 3. The average waiting time for coil removal is:

4. The average waiting time for implant fitting (Nexplanon) is:

An average of 60 appointments (both telephone advice and F2F) are made available per week to book online, however, these are integrated clinics, and all offer mixed services, not just contraception. Therefore, this information is not held, as defined in Section 17, Freedom of Information (Scotland) Act 2002.

Borders Sexual Health do not and have never had a waiting list apart from during lockdown in 2020 for 3 months.

Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
