## Freedom of Information request 579-23

## Request

In 2022/23 and 2023/24 so far.

- 1. What were the costs associated with delayed discharge in this health board?
- 2. What is the cost per day of delayed discharge in this health board?
- 3. What is the cost per bed of delayed discharge in this health board?
- 4. How many days have been lost due to delayed discharge?

## Response

1. - 3. This information is not held by NHS Borders, as defined in Section 17, Freedom of Information (Scotland) Act 2002.

However, under Section 15 Duty to Provide Advice and Assistance, there is no generally accepted 'standard' cost for a delayed discharge. Costs are typically estimated using data published within the Scottish Health Service Cost Book. NHS inpatient bed costs are costed at specialty average cost per case covering the average length of hospital stay, inclusive of all treatment costs incurred prior to any delay to discharge. It is generally accepted that the cost of a delayed discharge will therefore be lower than the 'standard' inpatient cost per bed day when averaged across the overall number of bed days.

The request for a review should include your name and address for correspondence, the request for information to which the request relates and the issue which you wish to be reviewed. Please state the reference number **579-23** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
